Tom received a few edits to the by-laws. Will resend for further review. The club will need to get a membership vote on the new by-laws since voting eligibility

will be changing for a class of members. This will be a good time to test new voting procedures.

There was an anonymous donation for the youth WV4+ heading to Nationals. The donation covers a large portion of the girls cost and is greatly appreciated.

i. Ad hoc committee updates

There was a suggestion to reach out to the membership and ask that they write to their representation to push the floodwall agenda. The boathouse relies on the budget being passed as is.

1. 2015-16 Budget update #2 Budget was discussed earlier. It was suggested that we keep Paypal open for some members.

ii. Masters Coaches update

The candidate turned down the coaching position later than planned. The plan is to keep the job posting open and lower program fees for master competitive programs. Practices will be un-coached with lineups and workouts provided by Eric and Cory. Members can also join the development team if they wish to be coached. Boats going out will still need a launch to accompany them as it is in the policy manual. Southeast Regionals and Masters Nationals will be an extra expense. There was a suggestion to have junior members run a launch to help out but they would need a license to drive a launch. Another suggestion to allow for a waiver to go out without a launch to make sure the program stays intact. There was a motion for the waiver and to approve a reduced program fee of \$100. Eric and Cory will make lineup and workouts.
