# 1. Music City Erg Sprints Review

David reported that the first Music City Erg Springs race went very well. The participants were pleased, Harpeth Hall was pleased, and there is room to grow.

# 2. Dock Extension Project

Al reported that the Board of Directors voted for two extensions to the dock for a total cost of \$3000. Eric Gehrke agreed to get the necessary approval from the Army Corps of Engineers. A junior rower will work on the dock as an Eagle Scout project. Jim will be the MAC liaison for the project.
