	Pas de Deux was badly damaged and will be taken to Oak Ridge to be fixed. It ran over a large log close to shore during HP camp. Tim Searles of Oak Ridge is the person who repairs boats. He will examine it, and Leonard Insurance will then determine whether it is totaled or not. Policy gives Board discretion to assess fees to rowers if Board determines damage was caused by negligence. Board will have to decide whether to do that. People sign an equipment waiver saying that Board can remove them from club without refund if we determine that	

	their actions warrant this ("removal with	
	cause"). Liability policy is technically only applicable to uncoached rows. Parents sign a liability form also. Says athlete can be dismissed from the team if they don't take care of equipment. Nothing about payment. Discussion about shat consequences should be and whether charges should be assessed (e.g., \$250.00 deductible) to athletes or parents. The general consensus was that the coaches should obtain all the facts and make a decision about appropriate consequences. Cory will talk with Emily C. further about the incident. The Board agreed that if athletes or parents will be assessed the cost of damages to equipment, the policy needs to be announced clearly to the	
	membership. Board is unhappy to have a boat out of commission. Maggie talked about masters and juniors not taking care of equipment. Need to have CTJ meeting with entire membership about caring for equipment. People need to have a safety lecture and be re-trained regularly - once a year at least. Maggie volunteered to work on equipment safety committee. Meg agreed to help.	
	Float Captain Update- Don Sullivan has been doing a good job as float captain. He is keeping the bumpers in good repair on the dock. He is awaiting permission from Corps of Engineers to see if we can add one more section to the dock. This will allow us to launch 2 8s on each side.

	Competitive Sculling Group Programming Proposal See proposal attached to agenda. Steve summarized - multi-year expansion of sculling w/in NR. Starting to build interest. Proposal calls for sculling to be under the compumbrella. Mostly singles and doubles.	

	Proposal is to have practice in the early morning. Geared to people who already can row a single and want to get more competitive in regattas. Probably a 2-year process to implement all the learning programs on the sculling side. 3 coached practices per week in a.m. \$125 per practice/week (for season). We would add people to competitive team who traditionally have not participated. Don would be coach for now. He would be sculling assistant coach; would work in coordination with masters head coach. Evening practice will still include sculling; it is not just for sweep rowers. Saturday practice will be all together. Don would be focused on the scullers. Don would do this for the price of his annual membership dues. (Proposal is written generically, not specifically for Don, so it doesn't say this.) He will be in a launch. He can't row during practices. Medium term basis. He said if we get a coach who wants to do it, he would be happy to give it up. Lizabeth has offered to help as the program expands. Motion - send this out to the membership for consideration - unanimously approved. JAC Report - Summer programs went well. LTR wrapped up;
